- 1) Zone Briley Shoots:
 - Ben Kaplan 2020 requests:

Discussion on Zone shoot - club requirement to provide dinner. In Ludlow this year netted \$5700 /3 days. No \$ is needed upfront from the club. Require 6 fields. fitasc will have to be taken apart. Will get caterer for food and either sit in club or at picnic tables - no tent, etc. The price charged is up to the club, but can't be more than \$60 or people won't come. If it rains, they still shoot unless a storm - the Zone will be held THAT day. Zone is held at the HGC every 3-4 year. Held 2nd weekend of August.

2) Terms were discussed and agreed upon during the meeting – these were forwarded to the Zone Committee.

Briley - desire 7 fields but will do it with 6. There are 5 weeks in between the Zone and the Briley. This shoot was started by Ben Kaplan in 1986 and is considered the 30th biggest shoot on the country.

Board proposal on the table - HGC hosts the Zone 1 skeet and the Briley shoots in 2020. 1) Each event will be given 6 fields. 2) 2 Fitasc fields will remain open and members can shoot on them during the shoots and 3) The zone 1 shoot organizers will endeavor to return \$1500/per day plus the sum of \$2000 for the dismantling and reinstallation of the FITASC fields.
